TERMS AND CONDITIONS

BOOKING CONFIRMATION

- All bookings are made with PASCAL Education (Cyprus) Ltd.
- The booking will become binding between the parties only when PASCAL Education (Cyprus) Ltd receives the signed application form, signed terms and conditions and payment of the first installment.
- The contract will be subject to the booking terms and conditions and will be governed and construed in accordance with the Cyprus law.
- The persons signing the application form (parents or legal guardians) warrant PASCAL Education (Cyprus) Ltd that they have the authority and legal right to represent the registered student by this contract with PASCAL Education (Cyprus) Ltd on behalf of the registered student on the basis of all the contract terms and conditions.

PAYMENT

- Payment of 20% of the total fees is required to confirm the place and 80% is due two weeks prior to the commencement of the programme.
- All payments must be paid on time as stated on the application form. PASCAL Education (Cyprus) Ltd reserves the right to cancel the booking without any refund if this condition is not met.
- In the case of cancellation by the client, at least 15 days prior to the commencement of the programme, any amount paid to PASCAL Education (Cyprus) Ltd, except the registration fee, will be refunded. No refund will be made during the two weeks preceding the starting of the programme.

CANCELLATION OF THE PROGRAMME BY PASCAL EDUCATION (CYPRUS) LTD

- PASCAL Education (Cyprus) Ltd reserves the right to cancel the English Language Summer Programme. Hence, in the highly unlikely event of the programme being cancelled the full amount paid to PASCAL Education (Cyprus) Ltd will be refunded.
- No refund will be payable if PASCAL Education (Cyprus) Ltd is forced to cancel the programme due to circumstances beyond their reasonable control and which could not have been foreseen or avoided. Examples of such circumstances include but are not limited to: war, threat of war, riot, civil unrest, act of terrorism, act of God, flood or any other adverse weather conditions.

CANCELLATION OF THE PROGRAMME DUE TO COVID-19

STUDENT BEHAVIOUR

PASCAL Education (Cyprus) Ltd reserves the right to send a student back home during the programme if deemed that the student is incompatible with the general wellbeing of the English Language Summer Programme. In this case all additionally incurred costs will be borne by parents/guardians and no refund of the already paid amount will be made. Examples of unacceptable behaviour include, but are not limited to: alcohol consumption, threatening behaviour towards staff, other students or anyone else, use/possession of illegal substances/drugs, smoking, entering rooms used by the opposite gender, leaving the accommodation facilities without permission, bullying and similar.
