## NOTES:

1. On Registration the following are payable (total €2,500 for new pupils/€2,300 for continuing pupils):

• Admission Fee or Registration Fee €400 or €200

• Parents/Guardians Association subscription €30

Towards the annual Tuition Fees €2,070

- 2. The balance of the annual Tuition Fees is payable in 6 equal instalments (September-February)
- 3. \*1 Parents/Guardians Association subscription:
  - €30 per family for 1 child
  - €10 additionally per family per sibling
  - Parents/Guardians Association subscription for PASCAL Secondary Schools is paid separately.
- 4. Sibling discount of €500 is given on the Tuition Fees of each of the older children.
- 5. If the Tuition Fees are paid in full then the following discount applies:
  - 3% discount if the Tuition Fees are paid in full until 30 April 2023
- 6. Parents/guardians of continuing pupils are required to reserve places for the upcoming academic year between 9<sup>th</sup> 31<sup>st</sup> January 2023. Places must be reserved during the period stipulated with the amount of €750. This amount will be deducted from the total amount of €2,300 which is payable on registration for the upcoming academic year (see note 1 above).
- 7. \*2 Optional Extended Day Programme: The regular school day consists of 7 teaching periods. Pupils may choose to follow homework support and activities (sports, social or artistic) every day after the end of the regular school day. The annual fee for homework support is €800 and for activities €700.
- 8. \*3 Excursions: The excursions charge relates to the transportation cost only. Any other related costs (e.g. entrance fee, food) are payable separately.
- 9. The cost for the school uniform, the books (excluding the ones provided for free by the Cyprus Ministry of Education, Sport and Youth), the school transportation, the extra-curricular activities and the participation in competitions, conferences, etc. is not included in this pricelist. More information regarding these costs can be obtained from the school reception.







- 10. The fee for the external examinations depends on the subject/level/examination body and is charged separately.
- 11. Fees can be settled via credit card, JCC Smart, wire transfers, monthly instalments by credit card or standing order.
- 12. Tuition and other fees are reviewed annually. Any possible increment on the Tuition Fees has a cap of 5% on the fees of each Year group for an academic year.
- 13. Admission Fee, Registration Fee, Tuition Fees and Parents/Guardians Association subscription are not refundable under any circumstances as they guarantee (represent a deposit) a pupil's attendance at school for at least one academic year. Hence, this is not simply an advance fee payment.
- 14. The inability to continue with school lessons, for whatever reason, does not exempt the parent/guardian from the obligation to pay the school fees for the whole academic year. Any balance of fees due upon the departure of a pupil from the school, irrespective of the date of the departure, must be paid in full. In the event that fees of a pupil were paid in full and the pupil ceases to attend the school, no refund is applicable. The departure of any pupil in no way minimizes the school's running costs.
- 15. A Late Payment Penalty Fee of €50 per month applies if the payment is not made by the applicable instalment deadline.
- 16. The school has the right to withdraw scholarships, monetary prizes or discounts in case the fees are not paid by the applicable instalment deadline.
- 17. The Disciplinary Committee has the right to recommend the withdrawal of scholarships, monetary prizes and/or discounts in case of serious disciplinary incident or disciplinary code infringement.
- 18. For those pupils whose fees are met partially or in total by the Cyprus Government (such as Maronites, Armenians, Latins, repatriated Cypriots, Turkish Cypriots and so on), it is the obligation of their parents/guardians to settle the school fees according to the applicable deadlines irrespective of when the subsidy is received from the Government.
- 19. Enrolment in the subsequent academic year will be accepted only once the due fees and other financial obligations have been settled.
